It would, in short, consolidate all our programs into one inclusive, multigenerational facility. In addition to fostering a stronger sense of belonging and community, this option would...

a. Reduce the operational and maintenance costs associated with our current aged facilities.

b. Provide adequate, safe and user-friendly space for all ages. (and)

c. Offer a broader range of programs and activities for all of our residents. The project cost for this option would be approximately \$16 million. The survey was conducted by Liberty Opinion Research LLC July 6-11, 2016 between the morning hours of 10:00-11:30 AM and evening hours of 6:00-9:00 PM.
