Rev. Monsignor William J. Gallagher, from St. John Vianney R.C. Church, opened the 2006 Organizational Meeting and the 1<sup>st</sup> Meeting of the Year with the invocation.

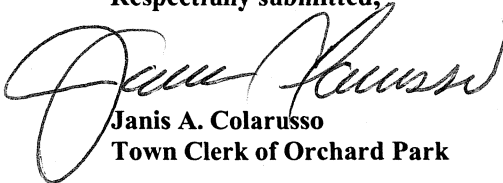
