Supervisor Colarusso read into the record the following: "If anyone appearing before the Town Board has a family, financial or business relationship with any member of the Board, it is incumbent upon that person to make it known under State Law and the Town Code of Ethics."

Erie County Legislator John Mills

Legislator Mills came to report on the progress of the first 60 days of 2013 for Erie County Government. He outlined the proposed Budget. The 8.5 million tax increase will not happen, instead the Legislature looked at cuts to the following: Fringe benefits account, Sheriff overtime (they hired new officers), Safety Net Program, and all vacant positions were cut out of the budget. The mild winter helped to save over \$1 million dollars that will be carried over to this budget. Funds to the Cultural Organizations, Parks and Roads remain the same. The County Clerk and Libraries receive additional money. Legislator Mills said they are going to replace the bridge on Lake Ave., and he is trying to get money to repair Lake Ave.

Regarding the Bills Stadium, Legislator Mills toured the Stadium with the Bills Officials and was impressed with the Bills Organization and their dedication to the Fans experience and thinks that they are committed to staying here past the 10 year lease period. He feels the \$133 million dollar municipal investment will serve the residents, as the Bills are part of the community fabric, and having the Bills play here brings in revenue and promotes the area.

The third item Legislator Mills discussed was the Erie County Library. There is talk of setting up a separate "Library Tax District" which will fund just the Libraries, which is similar to a school district or a fire district, and this will take the Library District out of the county umbrella and puts it into a separate tax district, which we do not need. He is opposed to this as it will take away the control the county has over what the libraries do in the Towns, and adds another layer of a taxing unit.

Christopher Clark, Director of Security for the Buffalo Bills

Mr. Clark, on behalf of the Buffalo Bills, thanked the Orchard Park Police Department for providing exceptional law enforcement services in the Town of Orchard Park. During the 2012 season, the Bills hosted over half a million people attending games and events at Ralph Wilson Stadium. It is an immense undertaking accommodating a capacity crowd of 73,079 fans and covering 197 acres. The Bills recognize on game day Orchard Park becomes one of the most populated towns in Western New York. In addition, as other employers in Orchard Park, they are thankful for the services provided by the Town's police department. With the utmost respect, the Buffalo Bills Organization presented an autographed helmet to the Orchard Park Police Department in gratitude for all their combined efforts. They truly appreciate their relationship not only during the football season, but throughout the year.

BUSINESS FROM THE FLOOR

Jacqueline Briggs – Ms. Briggs now has over 500 signed petitions in favor of the Town of Orchard Park obtaining the Baker Road School as Community Center where Seniors and other members of the community can gather. At the last School Board meeting, the seniors presented the petitions to the School Board, and many spoke in favor of the Baker Road complex becoming a Community Center. Ms. Briggs said that she hopes the Town Board will pursue obtaining the Baker Road Complex for an intergenerational community campus.

Alice Seydel – The Town Board has repeatedly heard about the inadequacies and safety issues of the current Senior Center, which is one of the worst in this area. The Senior Citizens here deserve better. Orchard Park is described as an affluent area with so much to offer. It seems the seniors are not valued in this community. They are good citizens, avid learners, shop here, pay taxes, volunteer, and are community leaders. She requested that the Town Board facilitate the acquisition of the Baker Road site.

William Dietsch – Mr. Dietsch had some questions regarding snowplowing. He also asked if the Town Board could reduce the speed limit on Ellicott where is comes around from Chestnut Ridge Road, as there are many people who walk along there. Councilmember Kaczor stated that it is a State road, but they would see what can be done.

David Schuster – Mr. Schuster said Green Lake was never intended to be a revenue generating cash cow, and Quaker Splash did not live up to its hype. As far as the Senior Center goes, how many of the Town seniors really go there. Mr. Schuster feels the Baker Road School should be sold to the highest bidder with the proceeds to go to pay down the cost of the new office building. The Town for the last few years has been struggling with the budget process and has made cuts to the Pavilion, Symphony and Code Enforcement, which serve the whole population, not just a segment of it. How much would the Baker Road facility cost to purchase, upgrade and maintain. The Town Engineer said retrofitting the Baker Road Complex for a Senior Center would be too expensive. In these tight financial times, this should not be a priority.

Kathryn Gorkiewicz - Ms. Gorkiewicz wondered how many seniors of the Town actually use the Senior Center. She would like the seniors to refocus on a different structure that Baker Road as she feels that the village location is a better choice.

ELECTED OFFICIALS & DEPARTMENT HEADS

Supervisor Colarusso said she would be willing to send a letter to the State regarding the speed limit on Ellicott Road. Regarding the Baker Road complex, she and former Councilmember Dave Buyer met with School Superintendent Matthew Mc Garrity, and CFO Jeff Petrus to discuss what each one would like to see happen. Supervisor Colarusso and Mr. Buyer were pleased with their conversation and the School was receptive to their ideas. She needs to discuss this with the Town Board, and they will continue to have conversations with the school.

Councilmember Kaczor said he was glad to hear Dave Schuster and Kathy Gorkiewicz express their view on the Baker Road complex as it is good to hear all sides on issues that affect the Town.

Highway Superintendent, Fred Piasecki, said the Highway is out picking up brush from the last wind storm.
