WHEREAS, Pursuant to the Real Property Tax Laws, Section 314, the Town Board of the Town of Orchard Park is required to designate an Acting Assessor

NOW, THEREFORE, be it

RESOLVED, that the Town Board does hereby appoint Milton S. Bradshaw as Acting Assessor for the Town of Orchard Park, effective March 14, 2005.

At this time, Supervisor Cudney read Milton Bradshaw's background and qualifications for the audience. She stated Mr. Bradshaw served as Town Assessor in the Town of Wilson and instituted a successful annual reassessment program. He is experienced in defending small claim assessment challenges and also performed independent appraisals of real properties for refinancing, mortgages and sales throughout Erie and Niagara Counties as an associate of Girasole Appraisals, Inc. The Supervisor stated prior to serving as Wilson Town Assessor, Mr. Bradshaw was an Assessor Aide in the City of Niagara Falls where he participated in a citywide re-evaluation.

She also added that Mr. Bradshaw graduated from Regents College, State University of New York with BS Degree. She also stated Mr. Bradshaw is past Vice President of the Niagara County Assessors Association and a member of the New York State Assessors Association. He has served on the YMCA Board and is a veteran having served the US Army as a Specialist Four (E-4). Supervisor Cudney introduced and welcomed Mr. Milton Bradshaw who was in the audience.

Councilman Jemiolo thanked Councilman Mills on his efforts in the search for a new Town Assessor on behalf of the Town. He stated that it was a thorough process with many qualified candidates. Councilman Jemiolo welcomed Milton Bradshaw as the new Town Assessor.

Councilwoman Ackerman stated that the Town Board had their first meeting with Mr. Bradshaw at the work session. There will be monthly meetings with the Town Assessor to inform the Town Board on changes and updates in the Assessor's office.

Councilman Mills appreciated the Town Board allowing him the time needed to interview candidates. He also thanked the personnel in the Assessor's office for their patience in the interim. Councilman Mills welcomed Mr. Bradshaw and looked forward to his employment.

Mr. Bradshaw thanked the Town Board on his appointment and their support. He stated that the Assessors Office offers information and service other than just taxes and it will be user friendly to the community.

New Business #2 Authorize the Supervisor to sign Agreement w/Marquis Eng. for Birdsong Park

5) THE FOLLOWING RESOLUTION WAS OFFERED BY COUNCILMAN KACZOR, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMAN JEMIOLO, TO WIT:

WHEREAS, the consultant selection process for the Birdsong Nature Trails has been completed and three professional firms responded to the Town's Request for Proposal, and since the Town received a grant from New York Parks, Recreation and Historic Preservation, which would require formal request formal request for professional services if the fee was more than \$25,000, the Town requests proposals from the two most qualified firms, and

WHEREAS, after the review of the proposals submitted, the Town Engineer determined that the Engineering firm of Marquis Engineering, P.C. will meet the needs of the Town on this project. The project, as set forth by the Town, consists of surveying, mapping and the preparation of plans for bidding the construction of 12,300 LF of trails (3,000 LF of existing roadway) with 1,250± LF of raised walkways, 5 bridges and 2 observation platforms, 4,000± LF of walking trails, and 2,900± LF of paved jogging trails, including signage and appurtenances, and

WHEREAS, the proposed scope of services and agreement with Marquis Engineering, P.C. is satisfactory and will accomplish the goals of the project that were set forth by the Town. The work has been organized into four major elements, with a lump sum fee for Preliminary Design, Final Design, Bidding and Award and General Service during construction of \$18,850.00 There is presently \$291,089.00 plus interest allocated under Capital Project H-23, Birdsong Park Nature Preserve for the project

NOW, THEREFORE, be it

RESOLVED, that the Town Board does hereby authorize the Supervisor to sign an agreement with Marquis Engineering, P.C., 6556 East Quaker Street, Orchard Park, New York, 14127, to provide professional services for the Birdsong Park Nature Trails Project in an amount not to exceed \$19,500.00 as recommended by the Town Engineer.

Supervisor Cudney announced that there would be a special meeting of the Association of Erie County Governments held at the Hamburg Town Hall at 3:30 PM on Thursday, March 3, 2005.
