8) THE FOLLOWING RESOLUTION WAS OFFERED BY COUNCILMEMBER KACZOR, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMEMBER MAJCHRZAK, TO WIT:

WHEREAS, the New York State Floodplain and Stormwater Managers Association (NYSFSMA) is a professional organization dedicated to promoting floodplain and stormwater management practices that reduce flood damages and protect water quality. Annually, the NYSFSMA hosts a 2-day conference. This annual conference provides an opportunity for members and other professionals to get updates on regulations, network, exchange ideas while acquiring updated knowledge and tools to promote sound floodplain and stormwater management throughout New York State, and

WHEREAS, the NYSFSMA Conference will be held from Monday April 8th to Wednesday April 10th in Buffalo, New York. After review of the conference program, it seems appropriate to attend only on Tuesday April 9th and Wednesday April 10th. The course agenda includes concurrent breakout sessions on topics such as the National Flood Insurance Program, LiDAR Surveys, and Floodplain Mapping and Streams and Stormwater, and

WHEREAS, the NYSFSMA Annual Conference is a valuable industry recognized source of information. This conference will also provide Jason Doktor and Wayne Bieler the necessary continuing education credits to maintain our Floodplain Managers Certification. The cost is \$100/member for Tuesday attendance and \$110/member for Wednesday attendance, which includes the conference and lunch. There is a \$10 discount per day per member for early registration by March 8, 2013 which results in a \$40 savings.
