WHEREAS, bids were received from four local companies for the Generator Diesel Tank Removal Project at the Municipal Center. The project was bid informally on a lump sum basis for a complete underground fuel tank removal. The bids were as follows; Russo Development - \$17,000.00, The Pump Doctor - \$15,200.00, Zoladz Construction - \$13,465.00 and Nature's Way Environmental - \$11,250.00. The Engineering Department has reviewed the bids of the four contractors who submitted proposals, and

WHEREAS, the low bidder for this project, Nature's Way Environmental Consultants & Contractors, Inc. (NWEC&C), has successfully completed similar projects in the Western New York area. Nature's Way Environmental has been found to have the qualifications and experience to perform this work adequately, and

WHEREAS, there is presently a balance of \$9,242.10 plus interest allocated under Capital H-88 "Municipal Buildings". In addition, the Town BAN included this work under Municipal Building funding.

NOW, THEREFORE, be it

RESOLVED, that the Town Board does hereby award the contract for the Municipal Center – Underground Fuel Tank Removal Project to the lowest responsible bidder, Nature's Way Environmental Consultants & Contractors, Inc. 3553 Crittenden Road, Alden, New York 14004 in the amount of \$11,250.00, as recommended by the Town Engineer.

WHEREAS, the original Yates Park splash pad rubber surface was warrantied for 2 years from the manufacturer. The Town's surface has lasted 8 years, being originally installed in 2007. The new proposed replacement system (Aqua-Flex) is warrantied for 3 years and is expected to last much longer for the Yates Park Splash Pad application, and

WHEREAS, bids were received from three bidders for the above referenced project. The project was bid informally on a lump sum basis for a complete surface removal and replacement using the new Aqua-Flex System. The bids were as follows; Playsites Plus Surfaces, Inc. - \$46,525.00, Surface America, Inc. - \$19,235.00 and Valley View Enterprise LLC. - \$18,972.00. The Engineering Department has reviewed the lump sum bids of the three contractors who submitted proposals. The lowest responsible bidder was Valley View Enterprise LLC., with a bid of \$18,972.00, and

WHEREAS, the low bidder for this project Valley View Enterprise LLC., has successfully completed similar projects in surrounding Municipalities. Valley View Enterprise is an authorized installer of the Aqua-Flex System, and

WHEREAS, the Parks Department capital account was closed and per the Parks & Grounds Department no additional funding was provided for maintenance in the Parks and Grounds budget. There is presently a balance of \$311,552.23 plus interest allocated under Recreation Fee account T.0000.0037.0737 that could be transferred,

NOW, THEREFORE, be it

RESOLVED, that the Town Board does hereby Authorize the creation of Capital Account H-20 "Green Lake Splash Pad", and be it further

RESOLVED, that the Town Board does hereby authorize the transfer of \$20,000 from T.0000.0037.0737 Recreation Fee account to H-20 Green Lake Splash Pad, and be it further

No one spoke.

ELECTED OFFICIALS & DEPARTMENT HEADS

Supervisor Keem attended the Rural Transit Volunteer Recognition Day, for Rural Transport Services. They are a non-profit transportation service in Erie County, and their main purpose is to provide transportation to seniors, low or moderate income individuals and disabled clients to doctor appointments, physical therapy, shopping etc. Every year Rural Transit hosts a luncheon to thank the volunteers, there are over 130 volunteers providing in excess of 16,000 safe rides a year. Among all the towns in Erie County, Orchard Park has the greatest number of volunteers. If anyone wishes to volunteer, call the Supervisor's office.

Councilman Sherry stated that they had the presentation for Communities Activities Center last week, and there are a lot of emails coming in in support of the Center, and there are a lot of questions too. He wants to encourage the feedback and questions from the community. They continue to work with the architects, they are scrubbing the numbers right now to become a little more specific on the general figures they gave to the Town. As more information comes in, they will be sharing it with the residents.

Superintendent Piasecki said that the Brush Contractor is starting the week of May 2nd. Highway and Parks are doing the cleanup work. At the compost site, Saturday hours are starting May 7th, from 8:00am to 12:00 noon and free mulch day will be May 14th from 8:00am to 4:00pm. He also stated that the State has come through with some extra money through their CHIPS program and it is called Local Pave New York \$35,328.36 in addition to the regular CHIPS funds of \$15,772.47.
