WHEREAS, the parties must execute such documents and related agreements in order to secure a settlement between the parties.

WHEREAS, as requested, the Engineering Department has received a proposal from NYSEG for the connection of nine (9) standard street light fixtures on Riley Meadow in the Riley Meadow Subdivision, as shown on the attached map. At present, there are six (6) single family homes currently under construction of the 23 sublots in Phase 1 of the Subdivision, and

WHEREAS, the 70-watt H.P.S. luminaires, which are owned by the Town, were installed with the installation of standard street light poles under PIP # 2012-03. NYSEG will maintain the bulbs, and the electric eye of the luminaires. The supply of electricity is not included in the price as the Town purchases their electricity from another supplier which is estimated to be \$42.03/ea. for an annual cost of \$378.27. The proposal is for a total of nine (9) luminaries to be connected at an annual charge of \$23.13 each; totaling annually \$208.22. NYSEG will provide new estimate sheets (see attached) as new rates become available.

#### NOW, THEREFORE, BE IT

**RESOLVED,** that the Town Board does hereby authorize NYSEG to connect a total of nine (9) 70-watt high-pressure sodium standard light fixtures in the Riley Meadow Subdivision at an annual increased cost of \$208.22 to the Consolidated Light District in accordance with the attached NYSEG proposal. Energy will be an additional (+/- \$378.27/yr., as recommended by the Town Engineer.

Tom Pieczynski – He spoke on behalf of the seniors of Orchard Park and the lack of space and parking at the Orchard Park Senior Center. He stated that they have to go outside of our Town to rent space at neighboring Senior Centers so they can hold meetings, programs and other functions. Mr. Pieczynski stated that this is an embarrassment to our Town. He stated that the school budget is about 400 times the difference than that of the senior funding.

Kathryn Gorkiewicz – She stated that the real number of how many seniors that attend or want to attend should determine the size of a new Senior Center.
