BUSINESS FROM THE FLOOR

Barbara Little – Ms. Little came before the Town Board at the 3/20/13 meeting expressing her concerns that the Town had reduced the Fire Inspector/Code Enforcement officer to a part-time position. Now she has found that there are over 14 new commercial projects and new residential developments taking place in Orchard Park and there is no way that two and a half Code Enforcement officers can keep up with the work requirements and fire inspections. The Town needs to reinstate the fire inspector as full-time. She also stated that she felt the Town Board does not really listen to the residents when they come before the Board with their concerns.

Kathy Gorkiewicz – Ms. Gorkiewicz stated that at budget time last year, she supported keeping the Fire Inspector-Code Enforcement as a full time position. She would like to see some investigation and reports on the mechanics of the building; plumbing, electrical, furnace; are the windows and roof in good repair, etc. regarding the Baker Road School that the Senior Council would like to purchase. The cost of this building is not going to be just the purchase price. It would be more with retrofitting plus the needed repairs. She does not want the Town to purchase a "white elephant".

Nick Taneff – Mr. Taneff stated that he had four items regarding 3964 California Road (DeMarco's Grove): 1) a report from the Building Inspector's office, dated 3/15/12 showing 13 violations, one of which it is noted that a night club exists there. This was a private residence, then it was rezoned to Industrial to allow buses to be parked there. 2) From the Town Clerk's office he obtained a copy of a Liquor License renewal which showed a multiple license, listing a restaurant, and a grove. 3) a letter from Mr. DeMarco sent to the Town Board attacking the Building Inspector for doing his job. 4) A building permit issued for a portion of this property to change it from storage (S-2) to Assembly (A-2). This "Change of Use" never went through the Planning Board. It does not look good for the Town Board to not check into this.

Dan Coughlin – Mr. Coughlin was concerned with the traffic situation at S. Buffalo St. and Jewett-Holmwood Rd. He hopes if the "No right on red" sign on north bound S. Buffalo St. is removed, that some other form of notification be put up to let people traveling northbound know that there is a green arrow on the southbound lane of S. Buffalo St.

Michael from Sen. Grisanti's office – He stated that today they held the 1st successful satellite office visit in Orchard Park. Five people did come in and he was able to help them. The next office visit will be May 15, 2013, 10:00am to 2:00pm.

ELECTED OFFICIALS & DEPARTMENT HEADS

Supervisor Colarusso stated that they will be reviewing all aspects of the Baker Road School before they even consider purchasing it. Supervisor Colarusso stated that the Town Board is aware of the situation at 3964 California Road and the Town Attorney is helping with some of the issues Mr.Taneff brought up.

Chief of Police Pacholec stated that he did review the NYS DOT traffic study and his officers are conducting their own survey. However, at this point nothing is going to change. Chief Pacholec said he would talk to Mr. Coughlin after the meeting to get his information.

14) THE FOLLOWING RESOLUTION WAS OFFERED BY COUNCILMEMBER KACZOR, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMEMBER MAJCHRZAK, TO WIT:

RESOLVED, that the Town Board does hereby approve Det. John Payne to attend NYS Fire Academy to go through the Fire Behavior and Arson Awareness course, May 6 to May 10, 2013. The cost to the Town would be \$108 for the registration fee. This is the first phase of the multi-tiered process to become certified as an arson investigator.

The resolution was unanimously adopted.

Highway Superintendent Piasecki stated that they have the sweeper trucks out and they are doing brush pickup. He announced the Free Mulch Day is going to be Saturday, May 11th from 8:00 am to 4:00 pm.

Town Engineer Bieler announced that the Orchard Park Village DPW, 100 West Highland Ave., is holding a free computer and electronics pickup on April 20th 10:00 am to 1:00 pm and is open to all Orchard Park residents.
