Which is consistent with the valuation of fiber optic cable located within the public right of way defined as Special Franchise property and,

WHEREAS, Amendments to Section 102 (i) of Real Property Tax in 1985 and 1987 were never intended to exclude fiber optic cable or other emerging technology from Outside Plant roll section 6 and,

WHEREAS, Until a recent decision by the Appellate Division, First Department removing fiber optic cable from Outside Plant roll section 6, fiber optic cable had been part of the Outside Plant assessment for over 25 years, and

WHEREAS, Across New York State hundreds of millions of dollars in tax base are in jeopardy of being lost creating a significant impact on Town, County and School tax,

#### NOW THEREFORE, be it

**RESOLVED,** that the Town of Orchard Park does hereby support the Erie County Assessor's Association and respectfully request the New York State Legislature to amend Section 102 (i) of Real Property Tax Law to defining, include and memorialize fiber optic cable as part of Outside Plant for tax assessment purposes consistent with the intent of a 1986 amendment to Section 102. Barbara Little – Ms. Little stated that she again presented at the last Town Board meeting her concern for a full time Fire Inspector or the new position of Code Enforcement Officer, whose major responsibility would be fire inspection and safety. With the amount of residential and commercial and residential building proposed and currently taking place, it is impossible for two and half positions in the Building Inspector's office to meet all their work activities plus all the responsibilities for the fire inspection and safety of the Town. At the March 20<sup>th</sup> Town Board meeting, Councilmember Majchrzak stated that he did not believe that there was any town in Erie County that had three full time Fire Inspectors. Ms. Little checked with other surrounding towns. In Clarence, which is similar to Orchard Park, had five full time Code Enforcement Officers, one of whom was listed as Fire Inspector. Some communities had even more. Ms. Little asked the Town Board again to consider a full time Fire Inspector as the Town is at risk as more building continues.

Patrick Keem – Mr. Keem commented on the Police Forum that took place last evening, and he thought it was a very informative presentation and well attended. He was glad to hear it may be held twice a year. It gave the community an idea of what happens within the Police Department and the officers that serve. He commended Chief Pacholec on the Forum.

James Lewis – Mr. Lewis had questions regarding property water and sewer lines. Councilmember Kaczor referred Mr. Lewis to the Town Engineer who would direct him with what he would need to do.

Pursuant to the law, within four (4) hours of a sanitary sewer overflow the service provider is required to notify the authorized designee of the municipality the discharge occurred in. As Erie County Sewer District No. 3 includes areas of the Town of Orchard Park within its boundaries, The Erie County Division of Sewerage Management would like to have the contact information you would prefer for these notifications – be it the Town Engineer, the head of the Town Highway Department or someone else in Town government.
