WHEREAS, the Town of Orchard Park, recognizes that plowing and de-icing town, as well as county roads, is in the best interest and safety of its residents, and

WHEREAS, Erie County and the 25 towns within the county have negotiated contracts which assure that the majority of the county roads within the towns would be maintained according to the same snow and ice control methods used on all town roads, and

WHEREAS, such methods have been approved by the Erie County Department of Public Works, and

WHEREAS, in the past, all costs of manpower, equipment, and materials have been calculated to the satisfaction of all parties, and

WHEREAS, any issues that have arisen during snow and ice control in previous years have been resolved by all parties involved, and

WHEREAS, a new contract between the Towns and Erie County is currently being negotiated, and

WHEREAS, on March 20, 2013, there was a tentative agreement between the towns and Erie County which included a 3 year term with an annual increase of 5.0% as was past practice, and

WHEREAS, this agreement was considered fair and within the budgeting confines of Erie County, and

WHEREAS, on April 16, 2013, Erie County made a counter proposal to increase the contract from 3 years to 5 years and to reduce the monetary increase to 0.5%, and

WHEREAS, the county proposed rate is one the towns cannot afford, and

WHEREAS, the budgetary planning for 2014 is going to be starting in many municipalities, and

WHEREAS, the deadline for towns to order road salt de-icier is now past.

WHEREAS, the Engineering Department received ten applications and interviewed six candidates that responded to the advertisements and postings, and the Town Engineer has concluded that the best qualified individual for the position is Jordan Kellerman. Mr. Kellerman has an A.A.S. in Construction Management from Erie Community College and has worked assisting the Engineering Department in survey work and construction inspection in the past. Jordan has accepted the challenge of construction inspection duties and responsibilities with enthusiasm and has performed his assignments with diligence. With the Sewer, Water & Lighting Department, Jordan has proven to be a dedicated and dependable employee, and

WHEREAS, funding for the Senior Engineering Assistant position is included in the Engineering Department budget. Per the white collar union contract, Jordan Kellerman, Senior Engineer Assistant level 009 Range D wage of \$25.38/hr is proposed, which is the next step above his current salary or an increase of fifty three cents per hour.

NOW, THEREFORE, be it

8) THE FOLLOWING RESOLUTION WAS OFFERED BY COUNCILMEMBER MAJCHRZAK, WHO MOVED ITS ADOPTION, SECONDED BY SUPERVISOR COLARUSSO, TO WIT:

WHEREAS, with James Putnam being hired as a police officer and Jordan Kellerman hired as Senior Engineer Assistant by the Engineering Department, the Sewer, Water and Lighting Department only has one employee remaining with a CDL license with tanker endorsement, and

WHEREAS, the Sewer, Water and Lighting Department employed three or more employees for the past 25 years with CDL licenses', which is required for the sewer jet truck operation. With the retirement of Rick Buss and now James Putnam leaving, only one employee is left in the Department with a CDL license. If that one employee is on vacation, out of Town, or sick there is no one in the Department left that has the required license. Crew Chief Dale Jolls has his permit but does not feel confident to take the driving test, and

WHEREAS, With Cmom being required in the Erie County District 3 Permit by NYSDEC, EPA Phase II regulations and the current public notification law adopted by New York State all SSO are reported and if not handled in a timely manner could result in fines or consent orders. Currently, several areas are maintained regularly with degreasers, jetting and or root cutting. Emergency blockages, if not opened, could surcharge and possibly flood basements with sanitary sewer effluent, and

WHEREAS, The Town of Orchard Park received 23 applications for the Sewer, Water and Lighting Department positions, eight interviews were conducted with Dale Jolls, Crew Chief and Town Engineer. They are recommending Robert E. Stachewicz to the position of Laborer for the Sewer, Water and Lighting Department, and

WHEREAS, Robert Stachewicz, of 51 Burbank Drive in Orchard Park has a CDL Class B license, Construction Safety and Health OSHA 10 hour & 30 hour Training, Hazardous Waste Worker OSHA 29CFR 1910.120 Training, Confined Space OSHA 29CFR 1910.146, Hazardous Communication Programs OSHA 1926.59(k), AWP Safety Training for Operations of Self Propelled Booms, Scissors and Personal Platforms, Lead Awareness Certification, Asbestos Handling Certification and CPR/AED & First Aid. Robert is currently working for Union Concrete and Construction Corporation with Union Local 210 of Buffalo and has experience from various construction companies on numerous sewer and water installations projects. Robert also completed the National Tractor Trailer School and Erie 1 BOCES–Harkness Career and Technical Center, Course work in Building Trades. Robert will need to pursue his tanker endorsement for his CDL License.

BUSINESS FROM THE FLOOR

Tom Pieczynski – Mr. Pieczynski spoke on behalf of the seniors and the need for a new senior complex. Their need for socialization is imperative and the existing senior center in Orchard Park is sadly lacking in comparison with other surrounding towns.

Barbara Little – Ms. Little commended the Town for hiring six police officers. She noted that there are numerous building projects going on in the Town and suggested that the Town Board reinstate the Code Enforcement Officer to full time and to possibly add another person.

Dave Schuster – Mr. Schuster asked the Town Board to forget about the senior center and borrow money to repair the Green Lake Dam.

ELECTED OFFICIALS & DEPARTMENT HEADS

Supervisor Colarusso – She stated that the Town Board reinstated the Code Enforcement Officer to a seasonal full time position until the end of the year and are interviewing for a part time person in the Building Inspector's Office. Councilmember Majchrzak stated that this was a unanimous decision by the Town Board. Supervisor Colarusso read a statement concerning the report conducted done by Wendel Inc. for the possible purchase of the Baker Road School for a proposed senior center. The Town Board agreed that there would have to be an appraisal to determine the cost before any purchase and reconstruction would occur. The BOCES rental contract would be a factor in the outcome of the purchase. Supervisor Colarusso spoke about the Police and their interaction with people with mental issues and senior citizens in need of help.

Councilmember Kaczor – He commented that the Town Board is researching the purchase of the school and other options if it doesn't turn out to be the right fit for the Town.

Councilmember Majchrzak – He stated that he wants to make sure that this purchase of the school is done right and it may take a significant time to make sure it is the right decision for the Town.

Police Chief Pacholec – He thanked the Town Board for allowing Lt. Joseph Ray and Officer Brian Lukowski to deal with people with mental issues and the senior citizens in need of help with their daily needs. He spoke of several incidents in the Town and stated that the Police are planning to include an underage drinking program through their Police Initiative Program. Chief Pacholec reminded residents to secure properties and vehicles to deter robberies. He reminded the citizens that the Buffalo Bills Preseaon opening game is on Friday, August 9, 2013.

Highway Superintendent Piasecki – He gave a report of the paving schedule in the Town.
