WHEREAS, following due and timely notice, a Public Hearing has been held, relating to the matter of the Amendment to the Zoning Ordinance of the Town of Orchard Park, which amendment provides as follows:

To rezone vacant land adjacent to 5948 Webster Road, located on the north side of Webster Road, west of Breem Street from R-3 to B-2 for the purpose of expanding the existing West Herr, Chrysler-Jeep parking lot, as petitioned by West Herr Properties.

WHEREAS, the Public Hearing was conducted at the Municipal Center 4295 South Buffalo Street, Orchard Park NY 14127 on the 7th day of August 2013 at which time all interested persons were given an opportunity to be heard, and

WHEREAS, no recommendations from the Erie County Dept. of Planning pursuant to Section 239-m of the General Municipal Law was received and filed by the Town Board, and

- Acreage fees shall be paid in accordance with §144(C) Schedule of Zoning Fees of the Town Code prior to publication of the Public Hearing Notice.

- This recommendation is contingent upon the applicant completing the project as proposed on the preliminary development plans received on 5/13/13, and as included in this motion, and shall revert to its original zoning classification if the project is not completed per §144-67 of the Town Code.
- The Planning Board makes the recommendation to have one driveway onto Webster Road to align with Errington Terrace with a berm to be constructed on either side with landscaping. A landscaped berm shall be placed north of the existing Webster and Breem corner lot house.

WHEREAS, the Town has received a proposal from NYSEG for the connection of five (5) standard street light fixtures on Hilltowne Drive in the Hilltowne II Subdivision. At present, there are three (3) single family homes occupied in this subdivision with another three (3) currently under construction of the 11 sublot Subdivision, and

WHEREAS, the 70-watt H.P.S. luminaires, which are owned by the Town, were installed with the installation of standard street light poles under PIP # 2012-02. NYSEG will maintain the bulbs, and the electric eye of the luminaires. The supply of electricity is not included in the price as the Town purchases their electricity from New Wave, which is estimated to be \$42.03/ea. for an annual total cost of \$210.15. The proposal is for a total of five (5) luminaries to be connected at an annual charge of \$23.13 each; totaling annually \$115.68. NYSEG will provide new estimate sheets as new rates become available.

NOW, THEREFORE, be it

RESOLVED, that the Town Board does hereby authorize NYSEG to connect a total of five (5) 70-watt high-pressure sodium Standard light fixtures in the Hilltowne II Subdivision at an annual increased cost of \$115.68 to the Consolidated Light District in accordance with the attached NYSEG proposal, as recommended by the Town Engineer. Energy will be an additional (+/- \$210.15/yr.)

The resolution was unanimously adopted.

WHEREAS, the Sewer, Water, and Lighting Department does not have the capability of installing the amount of linear footage +/- 5500LF required for this project in the necessary timeframe and because the cost is estimated over \$35,000.00, the watermain work must be completed through the formal bidding process, and

WHEREAS, in order to keep the project on schedule, the Advertisement for Bids should be authorized to be published on August 21, 2013. After agency approvals, plans will be available for purchase on September 30, 2013, and a bid opening on October 11, 2013. It is expected that the construction work will start mid October with completion of grading & seeding as spring weather permits near the end of May.

BUSINESS FROM THE FLOOR

Jackie Briggs- Ms. Briggs referred to an article "Future of Active Aging Adult Centers" which discussed the need to transform our current centers to adjust to the needs of our aging adult population. The "Boomers" are going to be looking to have a place for physical, mental, emotional and social stimulation in their centers, and that is what our current senior citizens are also looking for as well. The current senior facility in Orchard Park is in dire need of updating.

Kathy Gorkiewicz- Ms. Gorkiewicz stated that in the feasibility study for converting the Baker Road school into a senior center, she wants to see the total cost to cover the purchase, abatement costs, the cost of bringing the building up to code and to make sure that the cost of upkeep/maintenance for this building be included. She also wants these costs compared to the cost of the current center, and the impact it will have on the Town budget and taxes. She said no matter what is decided regarding the Senior Center, it should be put to a vote so the residents can decide.

Tom Pieczynski – Mr. Pieczynski stated that at the last meeting the Town priorities were explained to him and he asked why the seniors are always at the bottom of the pile. He was told "because they are" and "there are no requirements to do anything for the seniors". He found that shameful. Regarding the Green Lake Dam, the Town should do what it takes to get money from the state to help with the cost.

Barbara Little – Ms. Little stated the Town Board appointed David Jensen to a full time (provisional with no benefits) until the end of the year and are talking about adding another part time person. She wondered if this is an election time ploy to satisfy her, and others of like concern, so that we it would not have to be dealt with this until after the election. The current staff in the Building Inspector's office cannot keep up with the mandated inspections needed. After the Police Department, this office is the most important for the safety of the residents.

Alfred Szymanski- Mr. Szymanski said that historically, the Town has lacked sufficient leadership when seeking funding for the Community Center and as a result conditions at the Senior Center are not adequate for the seniors. In these financially difficult times, it is imperative that the Town Board seek funding from state and federal levels whenever prudent. The same applies to the Yates Park Dam restoration. The Town Board needs to seek appropriate funding for the betterment of our community.

ELECTED OFFICIALS & DEPARTMENT HEADS

Supervisor Colarusso – She stated that Andy Geist requested that David Jensen be reinstated to 40 hrs. a week and demonstrated that need. Making him provisional was all that the budget would allow. Supervisor Colarusso said she feels bad that some people are opposed to investing in a new senior center, as the seniors need an adequate place to go.

Councilmember Kaczor – He stated that when he talked to Mr. Pieczynski at the last meeting, he said that at budget time the priorities are set with Public Safety as #1, Infrastructure as #2 and Quality of Life as #3. When it comes to being the bottom of considerations at budget time, #1 is that recreation would have to be cut, and possibly the seniors. New York State does not mandate what is to be provided. He apologized if Mr. Pieczynski took it the wrong way. Regarding the Town seeking aid, he takes umbrage with that. As a community, we have worked very hard and extensively to pull grants into this community. Over the last 10 years, the Town has obtained millions of dollars in grants and are always working at obtaining more grants.

Councilmember Majchrzak – He stated that the Town Board is only a three member board, with two members being part-time. They work very hard doing the best they can with the resources they have. He stated that the Town does not have fire inspectors, they have code enforcement officers. The Town Board did not reappointed Mr. Jensen to 40 hrs. a week because it is an election year. It was because the Town Board listened to the Building Inspector and what his needs are for his office.

Police Chief Pacholec – He thanked the Town Board for his permanent appointment and the support they show for the Police Department. He reminded everyone of the Buffalo Bills home game next weekend.

Highway Superintendent Piasecki – He gave a report of the paving schedule in the Town and described the reworking of the intersection of Burton Road & Newton Road.

Application for Public Improvement Permit #2013-05 Ellicott Development

WHEREAS, we have received from Ellicott Development 295 Main Street, Buffalo, New York 14203, an application for a Public Improvement Permit to relocate the existing sanitary sewer on the former Saville's Parcel – 3910 North Buffalo Street, now owned by Ellicott Development, and

WHEREAS, the project consists of relocating the existing sewer and installing 5 new sanitary manholes, 521 lineal feet of 8" PVC sewer line and 4 wyes -1 for the O.P. Veterinary Hospital and 3 for future building connections, and

WHEREAS, the Town Engineer has reviewed the plan and have found it acceptable per Town code. All necessary fees and bonds have been received on August 21, 2013. Approval is contingent upon Erie County Dept. Environment & Protection, Division of Sewerage Management & Erie County Health Dept. approval which is anticipated next week.

RESOLVED, that the Town Board does hereby approve the application for Public Improvement Permit #2013-05, to relocate the existing sewer and install 5 new sanitary manholes, 521 lineal feet of 8" PVC sewer line, and lateral connections, as recommended by the Town Engineer.

Town Engineer Bieler – He stated that Wendel, the consultant for the Baker Road School, has reviewed the Environmental Report, (9/1998) compiled for the Asbestos Hazard Energy Response Act. Based on that report there is no asbestos building materials in the interior of that facility. Another clarification regarding the mold that was identified by Wendel, is only on the exterior of the building and could easily be remedied.
