BUSINESS FROM THE FLOOR

Barbara Little – She stated that there are numerous projects underway in the Town. New York State mandates regular inspections on public buildings be conducted annually or on a three year basis. All these requirements and responsibilities are under the control of the Building Inspector/Code Enforcement Department. She asked how the Town could have only two full-time and now as of two weeks ago, three full-time personnel, to handle all this work. She questioned why the Town has the money in the budget for part-time and seasonal employees in the Recreation, Engineering and Highway Departments, but not for the Building Department. Ms. Little stated there is a great liability on the Town to complete these inspections and planning for the next budget concerning the safety of the residents is imperative.

Dave Schuster – He asked Supervisor Colarusso if she was a property owner in Orchard Park or East Aurora.

ELECTED OFFICIALS & DEPARTMENT HEADS

Supervisor Colarusso – She stated she lives in Orchard Park, but does not own a home here, and the property in East Aurora she purchased is an investment.

Councilmember Kaczor – He stated that the Town Board works with the Town Accountant when increasing or decreasing personnel in comparison with other towns. The workload determines these actions. The cutbacks in personnel have been in different areas of the Town and they are based on what is good for the community. Councilmember Kaczor reported that it has been a gentlemen's agreement with political parties in the Town not to post political signs, but citizens do have the right to do so. Councilmember Kaczor said that research is being done on absentee landlords & new codes for the Town.

Police Chief Pacholec – He reminded the residents that there is a Buffalo Bills home game on Sunday. He stated school has begun and to stop for school busses.

Highway Superintendent Piasecki – He gave a report of the drainage schedule in the Town. He stated that the Town and County snowplowing contract expired on August 31, 2013. The Town is negotiating with the County to renew the contract for 31 lane miles in Orchard Park.
