Leonard Berkowitz, Town Attorney, stated that this structure poses a hazard with the potential of children getting into it and being injured, and the Building Inspector, Andy Geist, has determined that it should be demolished and deems it unsafe.

Virginia Grapensteder, Chase Home Mortgage (bank who holds the mortgage) requested that the Town hold off 30 days so that they could investigate this matter.

Loran Bommer, Attorney (for Richard Balisteri who is the owner of said property) asked the Town Board to wait on this decision as a purchase contact in place for this property, and he feels that demolition of this property is premature. He assured the Town Board that the property is going to be boarded up within 48 hours.

The Town Attorney recommended that the Town Board pass the resolution authorizing the demolition of said property and then the Building Inspector may use his discretion regarding the demolition. The Town Building Inspector has been trying to reach Mr. Balisteri for the past year, and he never responded.

Councilwoman Ackerman requested that the building be boarded up within 48 hours

BUSINESS FROM THE FLOOR

Lou Boehm – Mr. Boehm spoke against the WalMart project and feels that WalMart will leave this site after the ten year tax breaks are gone. He stated that the traffic problems from WalMart will be intolerable.

Mary Ann Grenda – Ms. Grenda asked the Town Board if they know who handed out the anti-downsizing flyer at the last meeting.

Dave Schuster – Mr. Schuster spoke against WalMart and their practices. He also stated that the legacy of WalMart will be a stigma against this Town Board.

Tom Carrow – Mr. Carrow stated that he received a letter from the Building Inspector denying his Stadium Parking permit. Mr. Carrow said he would pay for a private fire inspection as he does not want anyone from the Town on his property.

Barbara Little – Ms. Little thanked all involved in relieving the traffic congestion on Eggert Road during School hours.

Nick Taneff – Mr. Taneff applauded the Town Board for keeping up the fight against blight in the Town. He feels the Town code should have tougher laws, and heavy fines for the people who violate the Town code.

Russ Klass – Mr. Klass stated that there are two houses on Red Brick Road under construction which have construction problems and he outlined some of the problems. He thinks the Town Building Inspectors should be paying closer attention.

ELECTED OFFICIALS & DEPARTMENT HEADS

Councilwoman Ackerman said the NYS Library Association Empire Friends Roundtable Daniel W. Casey Library Advocate Award has been awarded to our Friends of the Library. The Orchard Park Friends of the Library was formed in 1991, and has continuously supported the Library.

Councilwoman Ackerman stated that most of the people who support the downsizing of the Town have other issues with government, not the Town itself. She asked that people not rush to judgment and take the time to evaluate the impact of this issue in the two towns who have already voted to downsize.

Councilman Dietrick stated that until WalMart complies with the Towns procedures and codes, he will not support their petition. When they do comply, he will give them the consideration that is due by the laws of New York State.

Councilman Dietrick stated that he is opposed to the one size fits all downsizing that is being presented by Kevin Guaghan, and he wondered why he picked Orchard Park. Councilman Dietrick stated this is all about politics and feels it is worth a few cents more in taxes to keep the extra council members for better representation in the community and to act as watch dogs for the community.

Town Clerk Janis Colarusso asked Ms. Grenda for a copy of the piece that was handed out at the downsizing meeting as she was not at that meeting and did not know about the piece that was handed out.

Police Chief Andy Benz stated that on Sept. 24th the state is going to be paving Rt. 20A.from Consumers Beverages to Freeman Road and no parking signs are going to be posted for that day.

Highway Superintended Fred Piasecki said the Highway Department has finished the road reconstruction on Ward Road, this years CHIPS project, and are working on the Short Drive reconstruction. Mr. Piasecki also stated that through the efforts of County Legislator Mills, New Taylor Road was overlaid last week.
