#### PRESENTATIONS

#### John Murray, Chairman of the Economic Development Committee.

Mr. Murray said the Economic Development Committee is composed of residents who want to encourage the development of businesses in Orchard Park that are sustainable over the long term and is consistent with the character of the town and the overall quality of life we enjoy here. They do not want to see growth just for the sake of growth.

In 2008 the Economic Development Committee developed a Strategic Plan, and this past year the committee updated it. The plan will be on the Town website soon. One of the strengths of the current plan is how it was formulated. They looked for the input from all the local business in the community. Every owner or manager of a business in Orchard Park was given the opportunity to input into the Plan. The current Plan has some action initiatives and some implementation initiatives that will be part of the focus of the Economic Development Committee in the next year. Mr. Murray encouraged everyone to view the new Strategic Plan on the web site, and contact them if you have any input you would like to share.

#### Senior Citizen of the Year – Jacqueline Briggs

Supervisor Keem said the reason that Orchard Park is so great is because of all the people who donate their time and effort to make Orchard Park a better place to live. One such person is Jacqueline Briggs. She has served on the Senior Citizens Task Force, as President of the Senior Council and on the Recreation Center Task Force, and has been a driving force for a new Community Activities Center. Supervisor Keem presented Jacqueline Briggs with a "Certificate of Appreciation" in recognition of dedicated service to the community and said "she is a great example for all of us, and someone who we certainly admire".

WHEREAS, On December 8, 2016, a final inspection was conducted of the public improvements installed in the Eagle Heights Subdivision Part 8, Phase 3. The project included the completion of Hearthstone Terrace and the installation of both Stone Bluff Court and Woodshire Court. The completion of this subdivision phase will allow 31 new single-family residential lots to be developed, and

WHEREAS, all work has been satisfactorily completed in accordance with Town specifications with the exception of the following, which will be completed when the weather permits:

٠	Install ten (10) poles and fixtures, all associated conduits, wiring, fuses, junction boxes, 'special'	pull boxes,
	etc., supply required spare fuses, pole, and fixture, and provide UL Inspection Certification.	\$24,000

- Place and fine grade topsoil, and hydro seed and mulch the entire ROW and cul-de-sacs. \$31.500
- Remove fill stockpile from sublot #42
- \$30,000 Finish grading drainage easement along sublot # 58, provide yard drains as needed for #4 Hearthstone Terrace, topsoil, and hydro seed and mulch this area \$5,000
- Install swale along sublot #66, backfill existing rear yard receiver, fine grade, hydro seed and mulch.
- \$3,500 Remove temporary turnaround on sublot #36, topsoil, fine grade, seed, and mulch. \$2,000
- Install all required street signage per Town Standards. \$1,500
- Fill the ROW completely for sublot #57, and place a berm on the south side of FI in sublot #57. \$2,500

WHEREAS, the Town is in receipt of the \$100,000 cash securities with the Letter of Credit per Town Attorney for the items noted above. A two-year maintenance bond in the amount of \$500,000 has been submitted along with all other necessary documents.

- 9. Free areas for recreation are not required.

- 11. The health and safety of adjacent properties is not effected.
- 12. A Negative SEQR Declaration is declared for the Special Exception Use Permit based on the Full EAF submitted on 10/31/16.

WHEREAS, New York's State Environmental Quality Review Act (SEQR) requires all state and local government agencies to consider environmental impacts equally with social and economic factors during discretionary decision-making. The Town must assess the environmental significance of all actions they have discretion to approve, fund or directly undertake, and

WHERAS, the Orchard Park Engineering Department has completed the SEQR Short Form for the Burmon Drive Reconstruction Project and has determined the project is classified as a "Type II Action" in accordance with section 617.5 (c)(11) of the SEQR regulations as replacement of existing utility distribution facilities. Actions that are classified as "Type II Actions" under the SEQR regulations do not require any further SEQR review, including an Environmental Assessment Form. The Short Environmental Assessment Form has been completed and is attached to provide documentation of this review and determination.

# NOW, THEREFORE, be it

**RESOLVED**, that the Town Board does hereby adopt that the Burmon Drive Reconstruction Project is classified as a "Type II Action" as the project will not have a significant impact on the environment and is precluded from further environmental review under Article 8 of the Environmental Conservation Law and 6 NYCRR Part 617, as determined by the Town Engineer.

WHEREAS, to complete the Burmon Drive reconstruction design work, existing soil conditions and pavement sections (subgrade/subbase) need to be known. With survey work completed, utilities located and design work well under way, test bore locations have been identified. Because of the extensive scope of the Burmon Drive Reconstruction Project, it is essential to perform a sub-soil investigation to know existing conditions to ensure that proper materials and methods are used for the construction documents development. A sub-soil investigation in the form of soil bores and split spoon sampling will render the data needed to make the engineering determinations required, and

WHEREAS, a proposal has been obtained from SJB Services, Inc. to perform four (4) soil bores to a depth of 25-feet along the length of Burmon Drive as well as prepare a report to detail the findings, and

WHEREAS, currently the Town has allocated funds under Capital Project Z-51 Burmon Drive Reconstruction for this project.

### NOW, THEREFORE, be it

**RESOLVED,** that the Town Board does hereby authorize the Supervisor to sign the agreement with SJB Services, Inc., 5167 South Park Avenue, Hamburg, NY 14075, to provide professional services for soil borings sub-surface investigation in the amount not to exceed \$2,700.00, as recommended by the Town Engineer.

They have brought the county finances into the information age. They have brought an outside firm in to perform a risk assessment about where some of the red flags are. They have received a national award for making a "Readers Digest version of the budget". Residents can go to the County website <u>www.erie.gov/comptroller</u>, where they have the taxpayers' checkbook. Every Friday they post all the bills that were paid. He thanked everyone for their time and service.

Supervisor Keem stated that one of his promises was to take the Budget Director's stipend and give it back to the community. He said that he did it again this year as he made checks out to 24 organizations in Orchard Park, and they will be listed in the paper next week.

Councilman Sherry said, according to the Buffalo News, the State Budget was released yesterday, and it looks like there will be nothing for local communities. In another article in the Buffalo News, the Director of Tax Services for the County said "when you look at your overall tax bill, the County portion is still the smallest portion that you pay". So Councilman Sherry went to the County & Town websites to see if was true. In comparison, the residents of Orchard Park pay substantially more to the County than they do to the Town of Orchard Park. Anyone can go to either of these websites and do the same. He felt it was important to set the record straight.

Town Clerk Orffeo stated that the Town/County tax bills were put in the mail yesterday, so the residents should be receiving them soon. He mentioned that residents can go to the Town website to review their tax bills, and there is a link to the County website.

Highway Superintendent Piasecki said the Highway crew is out picking up brush, Christmas trees and are focusing on drainage work.
