
Affidavits of Publication and Posting of the Legal Notice of the Public Hearing were presented, read aloud and filed with the Town Board by the Town Clerk.

RESOLVED, that the Town Board does hereby authorize to receive and file the following communications as entered on the agenda: 1) State Senator Volker: the state budget is including a multi-year Capital Transportation Plan that will make critical investments and improvements to the local and statewide transportation infrastructure. By investing wisely, reliable transportation will attract new businesses and jobs to the community. He states that without passage of the Transportation Bond Act that will be on the November 8th ballot, the entire statewide transportation plan will need to be reworked, putting critical local projects in jeopardy, and, 2) The Legislature of the County of Erie: has designated November 1st to November 30th as the annual thirty-day time period within which a land owner may request predominantly viable agricultural land for inclusion to a certified agricultural district accordance with § 303-b of NYS Agricultural & Market Law. BUSINESS FROM THE FLOOR

Linda Flowers, 66 Woodview Court: She asked for an update regarding the flooding in her neighborhood on Woodview. She asked if the Town could dig out some of the silt from the stream under the bridge at Highland Avenue and Forest Avenue to relieve some of the backflow. The Village, Highway Superintendent Piasecki and Councilman Mills are scheduled to meet to try and resolve some of the problems. The US Army Corps of Engineers requires a permit to do work in the stream. If a permit is required, it will take some time to a permit.

Nicholas Taneff, 279 Summit Avenue: He congratulated David Jensen on his new position.

David Jensen, 7 South Davis Street – he thanked the Town Board for giving him the opportunity to start as a part-time employee with the Building Department and progress to a full-time employee. He stated that he will do the best job he can for the Town of Orchard Park.

Robert Frantsits, 4275 California Road: He was asking about drainage near his home. Town Engineer Bieler explained the drainage history of Cobham Drive, which doesn't affect his property. Supervisor Cudney stated that this problem seems to be a private property issue and not one the Town would be responsible for. Councilman Jemiolo told Mr. Frantsits if his plumber could contact the Town Board, they could help with a possible solution. The Highway Superintendent said an Erie County representative is scheduled to meet with him to discuss what can be done for Mr. Frantsits and his neighbors regarding the water issue, since this is a County road and right-of-way.

Peggy Kraft, 18 Timberlake Drive: She asked the Town Board for help in creating an ordinance regarding the housing of pigs as pets in a residential area. Ms. Kraft's neighbor owns a pig, which has caused her significant property damage, injured her dog and hurt another neighbor. Ms. Kraft stated that it a dangerous situation and hopes that the Town Board can establish a lawful solution. Supervisor Cudney suggested that Ms. Kraft could file in Small Claims Court for damages and restraint of the pig. Chief McCune stated that this situation has been ongoing for some time and the Dog/Animal Control Officer, the Building Inspector and the Police Department have been actively involved.
