The project scope of work involves the installation of approximately 3,772 linear feet of 8-inch water main and appurtenances on Timberlake Drive between Jewett Holmwood and Briar Hill Road, and

WHEREAS, the Town of Orchard Park Engineering Department has reviewed the itemized prices of the ten (10) contractors who submitted bids. Two mathematical errors were discovered which did not involve the two lowest bidders or the ranking of the bidders. Sergi Construction was the lowest responsible bidder with a base bid of \$414,808.45 that was below the Engineer's estimate of \$550,000 for the project, and

WHEREAS, Sergi Construction has successfully completed water main projects for the Town of Orchard Park and for various local government agencies including the Jewett Holmwood Waterline Replacement constructed in 2011. Sergi Construction has been found to have the qualifications and experience to perform this work adequately. Sergi Construction has been in business since 1993, and

WHEREAS, there is presently \$1,524,541.28 plus interest allocated under Capital Project H-48 "District Wide Water Improvements" for this and other projects, and H-48.8389.0459 has been setup for Timberlake Waterline replacement project.

# NOW, THEREFORE, be it

**RESOLVED**, that the Town Board does hereby award the Contract for the Timberlake Waterline Replacement Project to the lowest responsible bidder, Sergi Construction Inc., 775 Jewett Holmwood Road, East Aurora, New York 14052 in the amount of \$414,808.45.

With the subdivision construction work well underway, the submittals for the sewage pump station must be reviewed and approved so the parts and pumps can be ordered and installed. As in the past, the Town of Orchard Park will directly contract the professional specialty inspection portion for the Knoche Farm Estates Subdivision, and

WHEREAS, the Town Engineer has solicited services from a local consultant Delmar Electric Construction Corp., who has been involved with the past existing pump station electrical supply problems and is qualified and capable to complete this work in the necessary time frame, and

WHEREAS, the subdivision contractor is required to submit to the Engineering Department for all sewerage systems the project data sheets for technical review and approval. As each pump station design is unique including the site layout, pump configuration, electrical requirements and controls a technical review is required. Delmar Electric has performed consulting and repair services on our existing stations and their experience has proved to be invaluable in trouble shooting our current systems, and

WHEREAS, the work would include a full technical review of the submittals and inspection services when the pump station is installed. Delmar Electric has agreed to perform these services at an hourly rate of \$85.00. The estimated maximum time necessary to complete the work is 10 hours.

#### NOW, THEREFORE, be it

**RESOLVED**, that the Town Board authorize the Supervisor to sign an agreement with Delmar Electric Construction Corp., 21 Cooper Avenue, Tonawanda, New York 14150, to provide professional technical review and inspection for the pump station electrical supply and installations at Knoche Farm Estates in an amount not to exceed \$850.00, as recommended by the Town Engineer.
