#### **SECTION 1:**

#### Section 58-4 (D) Wild Animals and Dangerous Dogs

On April 1' of every year a report must be filed with the Town Clerk listing the physical location of where all dangerous dogs and dangerous wild animals will be kept. Such wild animals and dangerous dogs are defined as non-human primates, non-domesticated dogs and cats, bears, venomous snakes, constrictors, pythons, and certain crocodiles.

#### SECTION II:

#### Section 58-5 (B)

Violations of this Chapter shall be punishable by a maximum fine of \$250 or imprisonment for not more than fifteen days, or both with the exception of a violation of Section 58-4(d) for which the fine will be \$250 for the first offense and \$1000 for each subsequent offense or imprisonment for not more than fifteen days, or both

#### **SECTION III**:

This local law shall take effect upon filing in the Office of the Secretary of State or from the date of its service as against a person served personally with a copy thereof.

## **BUSINESS FROM THE FLOOR**

Anne Griesinger – Ms Griesinger wanted to inquire about the construction at Mystery Pond on Pawtucket, and wanted to know if there was any more work planned for it. She also inquired about the removal of the swing set at Pawtucket Playground. She knew it was cited as unsafe, but did not feel it was that bad. It was a very popular item at the playground, and there is nothing for the older children at the playground now.

Chris Weyer – Ms. Weyer said when Birch Grove did the brush pickup, they did a wonderful job. The new contractor the Town has had for the last three years is a nightmare. The new contractor does not pick up the soft debris, only the limbs. Then the soft debris sits all summer, sometimes in the roadway, until fall when the Town starts picking it up. This is a dangerous situation, and it needs to be addressed.

Gary Weiser - Mr. Weiser said he is looking for his bi-weekly address of what is happening with Burmon Drive reconstruction. Nothing is happening and it is just a mess. Hopefully there is another contractor lined up to get things rolling. He is just looking for answers.

Kathe Eskew – Ms. Eskew asked what precipitated the promulgation of the proposed local law regarding the installation of Solar Power panels.

Jeff Pedro – Mr. Pedro was also inquiring about the Solar Energy ordinance that has come out. He understands that the proposed Local Law does not allow solar panels on the front of houses. The panels he wanted to put on his house were black and would blend into the house itself. He works for CIR Electrical and has installed solar systems for homes, many of which are quite nice. They have done over 500 homes in WNY and this is the first ordinance that he has heard of where people are not allowed to put solar panels on the front of their house. He feels this is not a good precedence.

Sue Hogenkamp – Ms. Hogenkamp wanted to piggy back onto Ms. Weyer's statement regarding the brush and debris in Eagle Heights. She walks a lot and the huge piles of brush sticking out in the road has been a much larger safety hazard than the swings in the park that was taken down. The swings are sorely missed, she wants them replaced this year.

# **ELECTED OFFICIALS & DEPARTMENT HEADS**

Supervisor Keem said two different companies and our insurance company went around last year to evaluate the playground equipment and they determined what was unsafe and had to be removed. Unfortunately, we did not get a schedule of what was being removed and when. In the Pawtucket Playground the 2 -5 year old playground has been completed, and next year an ADA walkway and swings are going to be put in. As far as Mystery Pond on Pawtucket, two environmental people evaluated that, and determined that it was a safety and health issue that needed to be cleaned up. At this time there is still more work to be done on the pond.

Supervisor Keem stated that there has to be a better format for cleaning up all the brush & debris in the Town. Addressing Mr. Pedro's issue, he stated they are going to be taking another look at the Solar Law and tweaking it. He also stated that through Sen. Chris Jacobs, the Town has received a grant of \$75,000.00 for "Inclusive Playground Equipment", which is for children of all abilities to play and grow, to be put in the Orchard Meadows playground. The Town is going for another grant for the same equipment for the Burmon Road playground.

Councilmember Majchrzak said, regarding the Burmon Road Project, the Town is in a legal situation and cannot share a lot of information. But, the Town is making progress in having a contractor pick up where the other contractor left off. Hopefully, in the next week, the Town should get feedback to determine what direction the Town will take on this project. The plan is to have everything done this year except maybe the seeding and grading.

Councilmember Sherry asked if it has always been that the contractor only picked up brush and not the soft debris, and Superintendent Piasecki said yes. COUNCILMEMBER Sherry then stated that there is a law on the books that things cannot be put in the roadway or on the shoulder of a road, it is a safety hazard. The police have been reluctant to charge people who are doing that, and put out a Town-wide bulletin on Code-Red letting people know the law regarding this. This hazard has to be addressed.

Councilmember Sherry said the new Solar Panel Local Law is to clarify some of the law regarding issue, not to enact a new code. There has been some discussion about revisiting the Solar Panel code again and consider some exceptions to it. Any changes will be done through the Local Law process were residents have the opportunity to express their concerns. He also talked about the Eagle Heights issues of Mystery Pond, and the swing set, and stated the Board will find out more about it.

Highway Superintendent Piasecki stated that the Highway Department is overlapping with the Brush Contractor to get everything cleaned up. The property owners are responsible for the soft debris, and should bag it, or have their landscaper do that, for garbage pickup. He said that a full crew will be put up in Eagle Heights next week to clean the streets, from there on in it is up to the residents.

As far as the Pawtucket Mystery Pond, that has been on the Highway Department's list for a long time to be cleaned up because of the state it was in. They went in to fix the drainage, clean it out, and fix up the banks. They are now waiting for it to dry up a bit to finish the landscaping on it.

There being no further business, on a motion by Supervisor Keem, seconded by COUNCILMEMBER Majchrzak, the meeting adjourned at 8:00 pm (local time).
