#### **BUSINESS FROM THE FLOOR**

Sean Hopkins, representing Orchard Grove LLC. - Mr. Hopkins outlined the reasons they are requesting approval from the Town to place an identification sign on California Rd. for the proposed Orchard Grove development. He wants to work with the Towns departments and attorney to figure out a solution.

Andrew Romanowski, project sponsor for Orchard Grove LLC. – Mr. Romanowski stated they are trying to accommodate the neighbors request by not putting an entrance to the proposed project on Big Tree Road, so they are looking to the Town for help on placing an identification sign on California Road.

Jim Suplicki – Mr. Suplicki stated that Mr. Joe DeMarco has been parking new and used cars from automobile dealerships in his parking lot on California Rd., and this is against Town Code. Even with the property being rezoned to I-1, it is still in violation of the Town Code. Why is this being allowed and on whose authority has this been allowed to happen. It appears that the original Rich Stadium Commercial Parking Permits are being issued for purposes other than what they were meant for. With the rezoning of this property, and in view of the new Local Law putting a moratorium on new permits, will this extend to Mr. DeMarco's property?

Dan Kaczynski – Mr. Kaczynski lives near the DeMarco's property and has watched as the area has been altered. It used to be a beautiful area, now it is black top. He wanted to know if there are Town Codes regarding noise and time limits for operations for the Town because of the loading and unloading of cars on the lot and all the other noise that comes from there. Mr. Kaczynski does not even know what goes on at this property. Years ago Mr. DeMarco approached him saying he had to put up new buildings for his WINGS project, but Mr. Kaczynski said he is disgusted with what they have done with the property there. He said that he has so many questions as how it got to this point and is afraid for what else will happen there.

#### **ELECTED OFFICIALS & DEPARTMENT HEADS**

Supervisor Keem wanted to mention the 4<sup>th</sup> of July Parade next week and encouraged everyone to attend as it is always a good time.

Councilman Sherry said that it is the understanding of the Town Board that the parking has stopped at the California property. If there are still lingering questions, they can be followed up with the Building Inspector. The purpose of the moratorium on Stadium parking is to take a time-out and assess what is going on over there. One of the charges that went to the Comprehensive Plan Implementation Committee is that they take a look at that area over there and get back to the Board with some recommendations.

Building Inspector, Andy Geist, told Mr. Suplicki and Mr. Kaczynski to get in touch with him and he will explain spot zoning and answer their questions. Mr. Geist said that the Commercial Parking permits are not issued by the Building Inspector, they are approved by the Town Board.

Chief of Police Pacholec wanted to let people know that there will be roads closed off on the 4<sup>th</sup> of July for the parade. A bear was seen at the Orchard Park County Club on Saturday night.

Highway Superintendent Piasecki stated that road work is starting next week, and outlined the roads that will be worked on.
