PUBLIC INFORMATION MEETING

At 6:45 PM (local time) Supervisor Keem and the Mayor of the Village JoAnn Litwin called a joint Public Information Meeting to apply for funding to further develop the trail system located within Yates Park.

Affidavits and Publication of the Legal Notice of the Public Information Meeting were presented, posted on line and filed with the Town Clerk.

Supervisor Keem asked if there was anyone in the audience who would like to speak for or against the proposed local law. There is a sign-up sheet if you are in favor of this. There were 25 people who signed the sheet.

No one came forward to speak in favor or opposition.

2) THE FOLLOWING RESOLUTION WAS OFFERED BY SUPERVISOR KEEM, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMAN SHERRY, TO WIT:

RESOLVED, that the Public Hearing in the matter of the proposed hearing is hereby closed at 6:53 PM.

The resolution was unanimously adopted.

3) THE FOLLOWING RESOLUTION WAS OFFERED BY SUPERVISOR KEEM, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMAN SHERRY, TO WIT:

WHEREAS, the Town of Orchard Park and the citizens it serves recognize the value to the community of improving municipal parkland for public use, including Yates Park and,

WHEREAS, specific improvements to Yates Park, including the repair of damaged trails owned by both the Town and Village and also create new trails to allow for a continuous link to both the residential areas and commercial areas of the Town and Village of Orchard Park. The Town and Village of Orchard Park have joined forces to successfully implement this project. The project also includes the addition of other recreational amenities such as park benches and trash receptacles. These are priority enhancements that will draw more residents and visitors to the park;

NOW THEREFORE be it

RESOLVED, that the Town of Orchard Park fully approves and endorses the Town and Village of Orchard Park Yates Park Trail Development Project and affirms public and community support for it, and be it further

RESOLVED, that Town Supervisor of the Town of Orchard Park, Pat Keem is hereby authorized and directed to file a joint application (Town of Orchard Park as official applicant) for funds from the New York State Office of Parks, Recreation and Historic Preservation, Recreational Trails Program (RTP), in accordance with the provisions of Title 9 of the Environmental Protection Act of 1993, in an amount not to exceed \$200,000, and upon approval of said request to enter into and execute a project agreement with the State for such financial assistance to the Town of Orchard Park. The Town of Orchard Park will be responsible for all grant administration, oversight and reporting required through this application. The Town of Orchard Park affirms that start-up capital and the required match will be provided should an award be made.

The resolution was unanimously adopted.

COMMUNITY CENTER DESIGN PRESENTATION AND VOTE

Councilman Mike Sherry presented slides that highlight the 3 Exterior Architectural Design proposals of the future Orchard Park Community Activities Center. The plan is to break ground in the spring of 2018. Each of the plans were presented from a few different angles, and the community present at the meeting had the opportunity to fill out a ballot vote. Additionally, the voting for the exterior will be available on line for the next two weeks for the community to vote on. The 3 plans are: 1) Gabled, 2) Contemporary, 3) Prairie.

New Business #1 Local Emergency Management Mutual Aid Assistance

4) THE FOLLOWING RESOLUTION WAS OFFERED BY COUNCILMAN MAJCHRZAK, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMAN SHERRY, TO WIT:

WHEREAS, during a "major incident" communities are required to operate for the first 72 hours to manage the incident with the resources that they have. The Town of Orchard Park was fortunate that it was able to manage the impact of the 2014 November snow storm with personnel from the Municipal building, and

WHEREAS, there will come a time that an incident will require additional Emergency Management personnel to assist the Town. Likewise it is important that the Town is able to assist others in their time of need, to assist with their emergency situations and to get their municipalities up and running.

NOW THEREFORE be it

RESOLVED, that the Town Board does hereby authorize the Supervisor to sign the Memorandum of Understanding (MOA) for the Local Emergency Management Mutual Aid Assistance which will formally put in place an agreement to provide and receive assistance when events have inundated local emergency managers. This MOA will officially formalize the process of requesting assistance for additional Emergency Management Personnel to work within our Emergency Operation Center and to reciprocate that assistance when other communities need additional staff.
