WHEREAS, On August 22, 2014, a final inspection was conducted of the public improvements constructed in Knoche Farms Estates Subdivision Phase 1. The project included the construction of a portion of Alyson Drive and Knoche Way and the construction of Julia Place as shown on the attached location map. The completion of this subdivision phase will allow 33 new single-family residential lots to be developed. All work has been satisfactorily completed in accordance with Town specifications with the exception of the following, which will be completed as weather permits:

•	Complete the installation of 9 light bases, poles, and fixtures, and all associated	
	Conduits wiring, fuses, junction boxes, and 'special' pull boxes, etc., as per	
	Town and NYSEG details, and provide UL Inspection Certification.	\$50,000

•	Provide Landscaping for Phase 1 per plans (trees near retention pond and
