Town Attorney Bailey stated this is a second ordinance regarding parking regulations for New Era Field events and it adds that existing lots are not to be expanded and there are to be no new lots from the date of the Moratorium on stadium parking was passed in May 2017.

§141-12, New Era Field Parking

Section I: Purpose and Intent

- A. On any New Era Field activity date, residential property owners may permit parking for compensation on their premises in the R3 and R4 Zones that fall within a one-mile radius from the center of New Era Field. Said radius is described on a map which is made part of this chapter. Such map modifies a zoning map of the Town of Orchard Park referred to in § 1447.
- B. On any New Era Field activity date, the property owners in any B2 or I1 Zone within in the one mile radius described above may permit parking for compensation, providing they have obtained a commercial parking permit from the Town of Orchard Park.
- C. Only parking lots in existence on May 3rd, 2017 are allowed hereunder and all others are specifically prohibited.
- D. No such allowed parking lot, residential or commercial, shall be expanded beyond its footprint or parking capacity by number of cars beyond that which existed on May 3, 2017.
- E. The above referenced regulations are subject to the enforcement of the Town of Orchard Park Police Department or any other agency charged with the regulation of traffic, crowd control, and/or public health and welfare.

Section II: Effective Date

This local law shall be effective immediately upon the filing in the Office of the New York Secretary of State except that is shall be effective from the date of its service as against a person served with a copy thereof, certified by the Town clerk, ad showing the date of its passage and entry in the minutes of the Town Board.

The resolution was unanimously adopted.

RESOLVED, that the Town Board is hereby authorized to adopt Local Law #11 for the Year 2018 which provides as follows:

Town of Orchard Park to over-ride tax levy limit established in General Municipal Law §3-c

SECTION 1: Legislative Intent

It is the intent of this local law to allow the Town of Orchard Park to adopt a budget for the fiscal year commencing January 1, 2019 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law Sec 3-c.

SECTION 2: Authority

This local law is adopted pursuant to subdivision 5 of the General Municipal Law Sec 3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent(60%) of said governing body.

SECTION 3: Tax Levy Limit Override

The Town Board of the Town of Orchard Park, County of Erie, is hereby authorized to adopt a budget for the fiscal year commencing January 1, 2019 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law Sec 3-c.

Section 4: Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgement shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstances, directly involved in the controversy in which such judgment or order shall be rendered.

SECTION 5: Effective Date

This local law shall take effect upon filing in the Office of the Secretary of State.

Since the resignation of Robert Stachewicz effective August 17, 2018, we have operated with three permanent employees and two summer help positions. With the resignation of Robert Stachewicz, it is necessary to address the need for a permanent truck driver position for normal day to day operations and emergency call outs, and

WHEREAS, in accordance with provisions of the CSEA collective bargaining agreement, notices of the promotional truck driver opening were posted in the Sewer, Water & Lighting Department, and

WHEREAS, in response to the job posting, one of the Sewer, Water & Lighting Department's current employee requested consideration for a promotion to Truck Driver position, and

WHEREAS, the position is classified as non-competitive civil service title by the Erie County Personnel Department. Only one applicant signed for consideration for the position. An interview was conducted with the interested candidate by the General Crew Chief and subsequently by the Town Engineer.

WHEREAS, after consultation with Andrew Slotman, the Town Engineer has concluded that Ted Chirico should be promoted from Laborer to Truck Driver. Ted has been with the Department since 2014. He is a dedicated employee of the Town and has demonstrated the necessary work ethic and skills that are required for this position. He has also acquired the necessary CDL license with tanker endorsement.

NOW, THEREFORE, be it

RESOLVED, that the Town Board does hereby appoint Theodore Chirico, 2879 Angle Road, Orchard Park, NY 14127 to the position of Truck Driver in the Sewer, Water & Lighting Department at Job Level 2, Step 5 of the current wage schedule for CSEA Local Unit 815 effective September 19, 2018, as recommended by the Town Engineer.

WHEREAS, in response to the advertisement, the Town received 8 applications for the position. Three applicants refused interviews due to the salary offered. Three additional applicants were disqualified for not possessing the necessary qualifications required for the position as listed on the posting. Two applicants met the requirements necessary for the position, and would accept appointment both of the applicants were interviewed by Andrew Slotman, General Crew Chief of the Sewer, Water & Lighting Department, and myself, and

WHEREAS, after consultation with Andrew Slotman, the Town Engineer has concluded that Christopher Kuhnle should be hired as a Light Equipment Operator. Chris has worked in the construction industry for 6 years and has 3 years of experience working in a related municipal setting. Chris has multiple years of experience operating equipment that is listed in the Blue Collar Union contract as light equipment operator. Chris possesses a NYS Class A Commercial Driver's License with air brake and tanker endorsements.

NOW, THEREFORE, be it

RESOLVED, that the Town Board does hereby appoint Mr. Christopher J. Kuhnle, a resident of Orchard Park, to the position of Light Equipment Operator in the Sewer, Water & Lighting Department at a Job Level 3, Wage Step 2, as recommended by the Town Engineer.

Old Business #3 Approve Change Order #3 with Zoladz Const. for Bussendorfer Detention Pond

WHEREAS, the Engineering Department is requesting approval of Change Order #3 to the Contract with Zoladz Construction for Bussendorfer Regional Detention Pond Project, which consists of 4 items.

- **Item No. 1** is a credit to reduce size of the Stone Filling from Heavy to Medium for the pond's Emergency Spillway the size of the Heavy Stone Filling is not needed for this placement. This credit is worth \$190.50.
- **Item No. 2** is the deduction of topsoil placement on top of outlet control channel's Light Stone Filling this placement is not warranted. This credit is worth \$589.60.
- Item No. 3 work scope includes the installation of two (2) trail grates one just east of the Bussendorfer Pond across the access road and the other across the access road at the Webster Road Site; both for site security. The cost of these grates are \$6,440.00.
- Item No.4 includes the placement two (2) 18-inch thick Light Stone Filling down chutes in the pond due to erodible soils in the SW and SE 'corners' of the pond. The down chutes will terminate at +/- El. 773.00; +/- 2-feet below the pond's normal water elevation of El. 775.00. This item includes adding Medium Stone Fill at the outfall structure for erosion control. The cost for this work is \$14,369.24.

WHEREAS, if approved, this change order would increase the Contract amount of \$1,467,645.70 to \$1,487,674.84, representing an increase of 1.36%, and this work will add a week to the Contract.

BUSINESS FROM THE FLOOR

Dave Schuster – wanted to know when the Planning Board would have their Solar Report ready for the Town for Public review, it has been sixty days. At the work sessions, sidewalks around the High School were discussed, and it was stated that the county does not have the money to do it, and the Town does not have the money to put them in. But, the county can spend millions on New Era Field for luxury seating, and the Town can spend millions for a new Community Activities Center.

Eric M - stated that the residents around New Era Field do not have to get commercial parking permits as they are inconvenienced and have to protect their property. But there are several residentially zoned lots that do not have houses on them, and he believes they should have to get a permit as well. They are operating a business and should have to abide by the same laws and rules as a commercial property. He also stated that some of the lots are so jammed with vehicles that if there ever was a fire, no emergency vehicles would be able to get through.

The resolution was unanimously adopted.

Erie County Legislator John Mills discussed the many different programs that the County has available to its citizens. He noted that the County in the third quarter of the year is 14 million dollars ahead in sale tax revenue, and he is going to work to direct these funds towards the infrastructure in Erie County. Legislator Mills said the County budget process starts October 15, and he does not expect any increase in taxes. He also said he would work with Supervisor Keem regarding sidewalks around the High School on Freeman Road.

Councilmember Sherry talked about an ad that put in the Bee by the "Taxpayers United of Orchard Park" which said "Say No to increasing the Town Board to 5, Say No to higher taxes". This confused the Town Board because they have no idea who is putting this out or why they would do this. The Town Board has not discussed it, and there is no vote coming up on right sizing the Town Board. If someone wants to put forth a debate on this issue, they should acknowledge their stand and step up and identify themselves. This is public issue. He feels that this ad, put in the only Town wide distribution of the Bee, was politically motivated and manipulative.

Councilmember Sherry shared his opinion about restoring the Town Board to five members. First of all he stated that the Town of Orchard Park is about 45 sq. miles, has 27,000 residents, approximately 100 employees, 4 unions, 20 some committees, boards and task forces, an annual combined operating budget of 32 to 35 million dollars annually, and a full range of services for the residents. The current board consists of three members, with one full time. There are only a handful of boards in New York State that operate with 3 members, doing so risks less efficient governance, and or, burnout. Go to the Town's website and look at what each member of the Town Board is responsible for. Adding two more members would only add around \$43,000 to the Town Budget.

This issue came up long before Councilmember Sherry was in politics, at that time he made the point that all the decisions regarding the Town are in the hands of three people instead of five people. The downsizing of the Town Board narrowed representation of the people. His opinion, even though it has not been discussed, is yes, we should right size the Board. It would be in the best interest of the community. So this should be opened up to the community for discussion.

Highway Superintendent Piasecki stated they are paving Vistula Ave, just completed micro paving Seufert Road, are doing drainage work and site work at the Community Activity Center.
