Amending Chapter 58.Dogs. Section 58-4 Seizure; Violations Enumerated. Subsection C(2) and C(3) Dangerous Dogs

### **SECTION I:**

### Section 58-4 C(2) Dangerous Dogs

Any person may make a complaint of any attack upon a person or an attack, chasing, or worrying of a domestic animal to a Dog Control Officer. Such Officers shall immediately inform the complainant of his right to commence a proceeding as provided in Section 123, Subdivision 123(1) of the Agricultural and Markets Law.

### **SECTION II:**

### Section 58-4 C(3) Dangerous Dogs

Any person owning or harboring a dog deemed dangerous by a Judge or justice pursuant to Agricultural and Markets Law, Section 123, will muzzle the dog at all times when the dog is outside his proper enclosure. The muzzle shall be approved by the Dog Control Officer.

## SECTION III:

This local law shall take effect upon filing in the Office of the Secretary of State or from the date of its service as against a person served personally with a copy thereof.

### **BUSINESS FROM THE FLOOR**

Kathryn Gorkiewicz spoke of Chief Pacholec's work demands versus his pay rate. She feels he should have more supporting staff and more compensation for his position and duties. She also spoke of the Rails to Trails project. She inquired if the trails are on private property could grant funding still be used? She also stated private residences would be in jeopardy of losing privacy and security.

Sean Mets expressed his displeasure of the leaf pick up this past year. His phone calls have been met with excuses of understaffing. He would like this addressed.

Pat O'Brien spoke of the short comings of the previous Town Board meeting. He was displeased with the fiscal responsibility of the Town Board. He would also like to see some members on the Town Board replaced.

Gary Doster spoke of his disapproval of Rails to Trails in suburban neighborhoods. He stated there is no need for a linear park here. There is a large County Park less than 5 miles away. This trail would sacrifice the security of homes by offering back door access to the public. It would also be a liability risk, any injury on the trail would be the responsibility of the adjoining homeowner and the trails have no parking available. The trail would also cross the very busy intersection of Jewett Holmwood, Freeman and South Freeman Road. A crosswalk at this location would be dangerous. He would like to see the Town Accountants give a short and long term cost of the trails and requests the Town to do an independent cost analysis, safety and environmental impact study.

Bridget Pacholec spoke of the "Fair Market Value" of the Town's Police Officers, Lieutenants and Chief of Police. She inquired about the amount of money the residents would be saving and what they would be sacrificing by cutting or freezing salaries in the Police Department.

He apologized to citizens for being without power New Year's Eve for 12 hours and thanked Highway Superintendent Piasecki for quickly getting generators out to the traffic lights. His fast actions saved the Police Department many man hours of work. He also thanked the Orchard Park residents for their patience throughout the Bill's Season.

Highway Superintendent Fred Piasecki stated he has 2 crews picking up leaves with loaders and trucks equipped with large leaf machines taking advantage of the milder weather. Christmas trees will be picked up and taken to the compost site.
