BUSINESS FROM THE FLOOR

Michele Poitras is an Orchard Park resident, on the Board of OP Little League and the director of Travel Softball for OP Stars. She would like to know if there will be permanent lights set up at the diamonds at Brush Mountain Park. If there is no plan for permanent lights to go up there will they be able to have temporary lights put up?

David Schuster came forward to ask for the Planning Board minutes to be posted on the website, expressed his concern about Orchard Fresh leaving Orchard Park, and wanted to know why future meetings he has scheduled in the basement at the Town Hall (which he gets to use at no charge) are being asked to move to the CAC where they will have a charge.

Tamara Manly came forward to inquire about modifying the Town's Noise Ordinance. She asked that it be more specific about what constitutes noise and how loud it can be. She also wants a penalty to be instituted (fines or jail time).

Patricia Meckes stated she represents "The Citizens Against Wind Turbines In Lake Erie." She would like to ask Orchard Park if they will stand with them against the Turbines in Lake Erie. She stated the arguments against them. Governor Cuomo is trying to put it through in a 30 day budget and asked for people to act fast.

ELECTED OFFICIALS & DEPARTMENT MANAGERS

Supervisor Keem stated the Town is looking into other supermarkets to replace Orchard Fresh. He is also willing to look into adjusting Town Noise Ordinance Codes to make things better for the community. He also will be issuing a resolution to oppose Governor Cuomo's plan to have home rule taken away from the Towns. He also spoke of the Corona Virus and how the Erie County website offers helpful information and links to other reputable resources.

Councilmember Majchrzak asked for copies of the noise ordinance complaints from Tamara Manly.

Councilmember Flynn announced the "Councilmember on the Corner" dates. The first is April 25 from 9-11 at Tim Hortons near the Stadium at 3239 Abbott Rd. Orchard Park, the second is June 20 from 9-11 at the Grateful Grind Café in Chestnut Ridge Park. This will continue on a bi-monthly basis. He also plans to draft a Town Social Media Policy which he will present at the next Town Board Meeting. He would like to have it adopted two weeks later. After this is adopted we can begin Social media accounts with the residents of Orchard Park. He would also like to revise the time and dates items for the Town Board meetings are due to the Town Clerk in order for the agenda and documentation to be accessible sooner to the public and Board members.

Town Clerk Orffeo stated getting the information for the Town Board Meetings has been an issue for years. If the deadline dates are changed it wouldn't prevent Department Heads from adding emergency items at the last minute. It would be incumbent for the Board to stick to the deadline and move items to the next Board meeting if they aren't available in a timely fashion.

Chief of Police Wehrfritz thanked the Town Board for appointing the two full time Dispatchers and welcomed them.

Highway Superintendent Piasecki stated they are trimming trees and starting drainage projects and their mechanics are getting the road sweepers ready for operation. The Highway Department is taking calls from residents who have brush that is needed to be picked up now. They will compile a list and go out for a full day to pick up those piles. Regular leaf and brush pickup zones and dates will be posted in the paper in May. He also stated the rising beaver population in Birdsong Park has caused flooding and extensive damage. The DEC has been hired to remove the beavers.
