New Business #1 Accept funds from OP Community Activity Center Council for equipment

2) THE FOLLOWING RESOLUTION WAS OFFERED BY COUNCILMEMBER MAJCHRZAK, WHO MOVED ITS ADOPTION, SECONDED BY SUPERVISOR KEEM, TO WIT:

WHEREAS, the Community Activity Center needs to acquire fitness equipment to create and operate a fitness program, and

WHEREAS, the Orchard Park Community Activity Council is ready and willing to donate the sum of \$54,556.23 to the Town of Orchard Park to acquire that equipment, and

WHEREAS, THE Town of Orchard Park is ready and willing to accept the donation from the Orchard Park Community Activity Council in the above amount.

NOW, THEREFORE, be it

RESOLVED, that the Town of Orchard Park accepts the Orchard Park Community Activity Council donation of \$54,556.23 for the purchase of fitness equipment to be installed and used at the Community Activity Center.

The resolution was unanimously adopted.

New Business #2 Sign Parks & Grounds Agreement with Orchard Park Soccer Club

3) THE FOLLOWING RESOLUTION WAS OFFERED BY COUNCILMEMBER MAJCHRZAK, WHO MOVED ITS ADOPTION, SECONDED BY SUPERVISOR KEEM, TO WIT:

RESOLVED, that the Town Board does hereby authorize the Supervisor to sign the Parks & Grounds Agreement with the Orchard Park Soccer Club for the use of the fields and facilities.

The resolution was unanimously adopted.

New Business #3 Authorize Payment of Bills on Warrants by Supervisor during State of Emergency

4) THE FOLLOWING RESOLUTION WAS OFFERED BY COUNCILMEMBER MAJCHRZAK, WHO MOVED ITS ADOPTION, SECONDED BY SUPERVISOR KEEM, TO WIT:

WHEREAS, the Town of Orchard Park Board recognizes that the present coronavirus pandemic presents a variety of unique challenges in administering the Town's business, and

WHEREAS, among those challenges is paying legitimate operating expenses specifically related to the coronavirus emergency, and

WHEREAS, the Town of Orchard Park Board is willing to authorize the Supervisor to pay expenses without prior Town Board approval if those expenses are specifically related to the coronavirus emergency and which expenses are of such a critically time sensitive nature that they must be paid outside of the normal course of review and payment, and

WHEREAS, the Supervisor is ready, willing, and able to make a detailed report of the payment of such expenses at the Town of Orchard Park bi-monthly meetings, and

WHEREAS, the authority anticipated hereby extends only to the lifting of the various governmental states of emergency or to the termination of this authority at the pleasure of the Town Board,

NOW THEREFORE BE IT RESOLVED THAT:

- 1. The Town of Orchard Park Board hereby authorizes the Town of Orchard Park Supervisor to pay, without prior Town of Orchard Park Board approval, expenses specifically related to the comonavirus emergency which such expenses are of such a critically time sensitive nature that they must be paid outside of the normal course of review and payment, and
- 2. The Town of Orchard Park Supervisor is hereby directed to make a detailed report of such paid expenses at the Town of Orchard Park Board's bi-monthly meetings held either electronically or in person, and
- **3.** The term of the authority granted hereby extends only to the lifting of the various governmental emergencies or the termination of the authority granted herein by the Town of Orchard Park

The resolution was unanimously adopted.

New Business #4 Approve Wage Increase for Senior Center Kitchen Manager

5) THE FOLLOWING RESOLUTION WAS OFFERED BY SUPERVISOR KEEM, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMEMBER MAJCHRZAK, TO WIT:

RESOLVED, that the Town Board does hereby approve the request of the Senior Center Director to increase the wage of Kevin Kornowicz, part-time Kitchen Manager from \$13.50 to \$14.50 an hour.

The resolution was unanimously adopted.

New Business #5 – Not on Agenda – Reorganization of Parks & Grounds Supervision

6) THE FOLLOWING RESOLUTION WAS OFFERED BY SUPERVISOR KEEM, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMEMBER MAJCHRZAK, TO WIT:

WHEREAS, the Town of Orchard Park Board wishes to re-organize the administration and operation of the Town of Orchard Park parks, and

WHEREAS, Highway Superintendent Fred Piasecki presently is responsible for managing the Town of Orchard Park parks, and

WHEREAS, the Orchard Park Town Board wishes to appoint Edward Leak to take Fred Piasecki's position as Chief Administrator of the Town of Orchard Park parks, and

WHEREAS, the Orchard Park Town Board wishes to cancel the stipend paid to Highway Superintendent Fred Piasecki for his duties as Administrator of the Town of Orchard Park parks, and

WHEREAS, the Orchard Park Town Board wishes to make these changes effective on April 1, 2020, and

WHEREAS, the post of Chief Administrator of the Town of Orchard Park parks is to be an annual appointment hereafter to be made at the Town of Orchard Park organizational meeting each year,

NOW THEREFORE BE IT RESOLVED THAT:

- 1. Highway Superintendent Fred Piasecki is hereby relieved of any and all of his duties related to the Town of Orchard Park parks, and
- 2. Town Recreation Director Edward Leak is hereby appointed the successor to Highway Superintendent Fred Piasecki in managing all of those duties related to the Town of Orchard Park parks previously managed by Highway Superintendent Fred Piasecki, and
- 3. Highway Superintendent Piasecki's stipend for his Town of Orchard Park parks duties is hereby cancelled and Town Recreation Director Edward Leak is granted an annual stipend of \$8,000 to be adjusted proportionately for the 2020 calendar with payments in full beginning in the 2021 calendar year, and
- 4. The position of Chief Administrator of the Town of Orchard Park parks is to be an annual appointment hereafter to be made at the Town of Orchard Park organizational meeting each year, and
- 5. These changes are effective as of April 1, 2020.

Councilmember Majchrzak stated that at the Executive Session there were issues regarding the regoranization of the Parks & Grounds Supervison that came up that he was not comfortable with.

RESOLVED, that the Town Clerk is to publish due in the Orchard Park Bee.

The resolution was unanimously adopted.

ELECTED OFFICIALS & DEPARTMENT MANAGERS

Building Inspector Steve Bremer said that they are receiving a lot of calls and are trying to help contractors work through this time.

Chief of Police Wehrfritz stated that the Parks are open in daylight hours and reminded people to keep up the Social Distancing. He also noted that the Dispatch Office is not open to the public, you need to call 911 or 662-6444 to talk to a dispatcher. When police respond to calls, he asked people to come out and talk to the officers, they do not want to enter homes if they do not have to.

Highway Superintendent Piasecki stated that they are starting to do brush and leaf pickup, and they are working with half crews.
