While we cannot move forward with the Alternate to dredge Acorn Cir. Pond at this time, Legend Excavating has agreed to hold their bid price until the end of 2021; and

**WHEREAS,** Ed Leak has provided two Parks & Grounds accounts with sufficient funding to cover the costs associated with this project. Money within the accounts was earmarked for the purchase of a Ventrac mower and pickup truck but have not been approved by the Board per Ed Leak, Parks and Grounds Department.
