WHEREAS, the Town of Orchard Park has a desire to retain experienced and well qualified personnel, and

WHEREAS, the Engineering Department is capable of providing inspection services internally for the Smokes Creek Farms Subdivision current anticipated workload, however, will not allow us to take on additional projects with the current staffing; and

WHEREAS, Daniel Hammond is a retired employee of the O.P. Engineering Department with over 30years' experience and knows our construction standards quite well, and worked well as a construction field inspector several times with the town since then; and

WHEREAS, Mr. Hammond pay is at a rate of \$38.00 per hour; and

WHEREAS, there is presently \$957,000 in Trust Account TA0000 20095 for this work. Additional funding was collected with Smokes Creek Farms Subdivision PIP #2021-01 fees in the amount of \$50,750.

NOW, THEREFORE be it

WHEREAS, the Town of Orchard Park seeks grant funding to perform a necessary study of the Poplar Ave. culvert to determine the best course of action to prevent further erosion, flooding and worsening sinkholes in the residential area of Hawthorne Drive; and

WHEREAS, the Town intends to apply for \$30,000 from the NYSDEC, estimated to pay 90% of costs associated with conducting a NYSDEC non-agriculture nonpoint source planning grant; and

WHEREAS, the Orchard Park Town Board hereby commits 10% matching funds in an amount not to exceed \$3,000.00.

NOW, THEREFORE be it

RESOLVED, that the Deputy Supervisor is hereby authorized and directed to execute all documents pertaining to the application and acquisition of said funding; and be it further

RESOLVED, that the Orchard Park Town Board authorizes the Deputy Supervisor to sign an agreement with C&S Companies, 141 Elm Street, Suite 100, Buffalo, New York, 14203, to provide professional services for the CFA Funding, Non-Agriculture Nonpoint Source Planning Grant, Poplar Heights Subdivision Culverts Application in an amount not to exceed \$4,435.00 as recommended by the Town Engineer.

David Zango Spoke of a drainage issue in his subdivision, Canfield Terrace and Royalcrest.

Edward Paolini also spoke of the drainage issue in his neighborhood of Canfield Terrace.

ELECTED OFFICIALS & DEPARTMENT MANAGERS

Deputy Supervisor Liberti congratulated Youth Court, Natalie Nawrocki and Town Clerk Remy Orffeo. He also stated that the survey is complete and ready to be offered to the public regarding Marijuana Dispensaries and onsite consumption.

Councilmember Majchrzak asked that we opt out of allowing Marijuana Dispensaries and onsite consumption in Orchard Park until there is a five man board on January 1, 2022. He stated after we opt in we cannot opt out. Waiting until 1/1/2022 would give Orchard Park residents a better representation. He also stated that revenue from the sales cannot be directed to the Police Department, it is directed to the B fund and General Fund.

Councilmember Flynn congratulated the Youth Court graduates. He also commended Officer Razor and Officer Kowalski for their kind and professional way of handling a situation where a resident fell at a restaurant last weekend. He also asked residents to write a letter of support for the Poplar Heights Culvert Grant, a template can be found on his web page.

Town Clerk Remy Orffeo thanked the Town Board and his staff for the Proclamation in his honor.

Deputy Highway Superintendent Ernest Matthews stated he will look at the drainage issues presented by the residents at tonight's meeting.

Police Chief Wehrfritz thanked the Town Board for supporting Youth Court. He also stated the Highmark Stadium will have a 4th of July fireworks display. He also stated South Buffalo Road will be closed June 18 and 19, 2021 for bridge maintenance.
