WHEREAS, Telco Construction of East Aurora has completed numerous projects, specifically for the Town and also privately throughout the Town. The Town Engineer has zero concerns about their capabilities to complete this job in a professional and timely matter; and

WHEREAS, the funds for this work have been allocated with capital account #AB-008.

WHEREAS, the coalition has completed a planning process that engages the public, assesses the risk and vulnerability to the impacts of hazards, develops a mitigation strategy consistent with a set of uniform goals and objectives, and creates a plan for implementing, evaluating and revising this strategy.
