WHEREAS, two companies, Southtown Audio Video and Cinema and Sound WNY submitted bids; and

WHEREAS, both companies are more than capable of completing this project in the time frame identified; and

WHEREAS, Cinema and Sound WNY was the lowest bidder at \$21,304.96.

NOW, THEREFORE be it

RESOLVED, that the Town Board does hereby award the contract for a "Commercial Grade AV System" to the lowest responsible bidder, Cinema and Sound WNY, in an amount not to exceed \$21,304.96 upon the recommendation of the Community Activity Center Coordinator.

WHEREAS, the following property located in the Town of Orchard Park, locally known as SBL #172.07-1-7 is presently zoned R-3; and

WHEREAS, the Town of Orchard Park has determined that it would be in the best interest of the community at large for said property to be rezoned Development and Research (D-R); and

WHEREAS, the owner of said property is purported to be The First Baptist Church; and

WHEREAS, a metes and bounds description and an accurate map/survey is on file with the Town of Orchard Park Town Clerk; and

WHEREAS, the present use of the property is R-3 and could be used for Two Family Homes, Tourist Homes and Multiple Dwellings (a complete list is available in the Town Clerk's office), and in rezoned D-R state the property could be used for Business and Professional Offices, Warehousing and Distribution (a complete list is available in the Town Clerk's office),

NOW THEREFORE, under the authority of the Town of Orchard Park Ordinances Sections 144-66 through 144-69, be it

RESOLVED, that:

- 1) Notice to adjoining landowners be sent as required by Section 144-67 concerning the proposed rezoning, and
- 2) A hearing to consider said rezoning be scheduled for Wednesday, July 20, 2022 at 7:00 PM in the Municipal Center, 4295 South Buffalo Street

Scott Gburek spoke of a property near his home that contained dilapidated vehicles and another that had a shed that was too close to his property line. He also asked why Orchard Park residents are not supplied with garbage cans.
