New Business #3 Authorize advertisement for intent to revise flood hazard information per the National Flood Insurance Program regulations.

4) THE FOLLOWING RESOLUTION WAS OFFERED BY SUPERVISOR MAJCHRZAK, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMEMBER LIBERTI, TO WIT:

WHEREAS, the Town received a request from Insite Development Services, LLC. (Insite) to place an advertisement per National Flood Insurance Program 65.7(b)(1) for intent to revise the flood hazard information generally located between Lake Avenue and the Hammocks Drive, along Smokes Creek approximately 650-feet upstream from Orchard Park Road to just downstream of Southwestern Boulevard. This is the revision of the flood hazard information at this location for the Aldi's commercial development in this area. Insite will reimburse the Town for the cost of the advertisement.

# NOW, THEREFORE be it

**RESOLVED**, that the Town Board does hereby authorize advertisement per National Flood Insurance Program 65.7(b)(1) for intent to revise the flood hazard information generally located between Lake Avenue and the Hammocks Drive, along Smokes Creek approximately 650-feet upstream from Orchard Park Road to just downstream of Southwestern Boulevard as recommended by the Town Engineer.

The resolution was unanimously adopted.

New Business #4 Award contract for the Lakeview Avenue Reconstruction Project.

5) THE FOLLOWING RESOLUTION WAS OFFERED BY SUPERVISOR MAJCHRZAK, WHO MOVED ITS ADOPTION, SECONDED BY COUNCILMEMBER FLYNN, TO WIT:

**WHEREAS,** bids were opened for the Lakeview Reconstruction Project on November 28, 2023. The project consists of total reconstruction/replacement of Storm Sewers, Waterlines, and Roadway, and partial reconstruction/replacement of the Sanitary Sewers; and

WHEREAS, the project was bid on a unit price basis for the associated waterline, sanitary sewer, storm sewer, and road restoration work items. The Engineering Department has reviewed those itemized prices of the four contractors who submitted bids. The Project also included two alternates for cold milling the roadway and construction of a park maintenance driveway and parking lot. This area can be used as a staging area for the current project and for future highway snow storage as well as various park uses. The Orchard Park Engineering Department performed a review of the four bids submitted, and compared them against the Engineer's estimate of \$3,890,229.68. The lowest responsible bidder with base bid and the two alternates is \$3,787,258.60. As discussed, the low bidder does switch from Occhino Corporation if alternates #1 and #2

are awarded. Both Occhino Corporation and Edbauer Construction reference checks were very positive and could complete the project; and

**WHEREAS,** contractor submissions were checked for math errors. No errors were identified. The lowest responsible bidder was McLaughlin Construction Corp. DBA Edbauer Construction (Edbauer Construction) for \$3,787,258.60 with Al and A2 Alternatives; and

WHEREAS, there is presently approximately \$2,791,397.00 plus interest allocated under Capital Accounting Projects, Lakeview HWY DB008, Lakeview Water FX011 and Lakeview Sanitary Sewer G0011 for this project work. An additional \$995,861.60 is recommended, this includes \$100,000.00 contingency and typically a unit price bid does not cost 100 % of contract. Edbauer Construction has successfully completed various storm sewer, water, sanitary sewer, and road reconstruction projects in the past. The contractor provided references on relevant experience and all gave positive comments.

# NOW, THEREFORE be it

**RESOLVED,** that the Town Board does hereby award the contract for the Lakeview Reconstruction Project to the lowest responsible bidder, Edbauer Construction, 2790 Clinton Street, West Seneca, New York 14224 in the amount not to exceed \$3,787,258.60 (Base Bid and Al & A2 Alternates); and be it further

**RESOLVED,** that the Town Board does hereby authorize the additional drawdown of \$995,862.00 from Highway bond funding approved but not issued on December 15, 2021 as recommended by the Town Engineer.

New Business #5 Award contract for the Traffic Study for the Intersection of Lake Avenue and North Benzing Road.

**WHEREAS**, the signal is on a County Highway, however, it is owned and maintained by the Town of Orchard Park; and

**WHEREAS**, in order to change its function, a traffic study needs to be conducted. Once the study is complete, it needs to be reviewed and approved by Erie County Department of Public Works; and

**WHEREAS**, the cost of the review permit is \$600.00 and funding is allocated under Account B03310 50444 "Traffic Control Contractual Expenses".
