MOTION MADE BY SUPERVISOR MAJCHRZAK to go into Special Meeting, SECONDED BY COUNCILMEMBER LIBERTI, WITH UNANIMOUS APPROVAL, THE MOTION WAS ADOPTED.

The Original Resolution was read into the record by SUPERVISOR MAJCHRZAK & then amendments were read into the record by COUNCILMAN MARIANO:

RESOLVED, that the Town Board does hereby approve, effective immediately that the exempt salary of the Chief of Police shall be 57% higher than the highest base salary of a police/patrol officer in the Town of Orchard Park Police Department, and be it further;

RESOLVED, for all other benefits: Holidays, vacation, personal leave, clothing allowance, longevity, life insurance, medical and dental contributions etc., the Chief of Police will receive to the same extent and with the same conditions as received by a command officer pursuant to the current Town of Orchard Park Command Officers Association Collective Bargaining Agreement; and be it further;

RESOLVED, that the Chief of Police will receive longevity at 7%, and be it further;

RESOLVED, that the Chief of Police will receive any future benefits negotiated between the Town of Orchard Park Police Command Officers Association.

THE MOTION WAS OFFERED BY SUPERVISOR MAJCHRZAK, WHO MOVED FOR ITS ADOPTION, SECONDED BY COUNCILMEMBER LIBERTI, Town Attorney Tim Gallagher called for a Roll Call vote:
