

# **Typical Sidewalk Section**



- All proposed construction is within the existing public or OPCSD ROW
- Permanent easements will be obtained where necessary prior to construction
- Property access releases will be required to blend to adjacent terrain, construct driveway tie-ins or plant replacement trees as needed
